- ❖ **SIVS Rules** - Queensland Transport has requested Clubs make their members aware of the SIVS rules. QT have advised that the rules should be given out when a car is first put of Concessional Registration but admit that this has not been happening at all service centres all the time. Clubs are therefore asked to make their members aware of the rules, the web site listing the rules is:-

- ❖ **Press Release.** The AHMF issued 2 press releases during the month. The first release relates to the **new classification system for heritage vehicles.** The Australian Historic Motoring Federation has agreed to a national classification dating system for heritage motor vehicles. The classification system is as follows:

Veteran built before end 1918 (no change)

Vintage built between 1/1/1919 and 31/12/1930 (no change)

Post vintage built between 1/1/31 and 31/12/1949

Vehicles manufactured after 31/12/49 are to be classified as Historic 50's, Historic 60's then continuing by decades.

Clubs are urged to use the above classifications.

The other press release relates to car crushing and the release appeals to members of the public to check with their local historic vehicle clubs to see if there is any interest in their old vehicles before sending them to the recyclers/wreckers.
